



LIMITED 90 DAY WARRANTY

Paraclipse, Inc. warrants this product to be free from defects in workmanship and material under normal use and conditions for a period of 90 (ninety) days from the date of original purchase.

Should service be required by reason of any defect or malfunction during the warranty period, Paraclipse, Inc. will, at its option, replace or repair at its service center in Columbus, Nebraska any part(s) that prove to have such defects during the 90 day period provided that the defective unit is returned to our service center in Columbus, Nebraska. This warranty is the exclusive express warranty for these products and is in lieu of all other warranties, it being understood that this warranty is the final expression of your warranty agreement with Paraclipse, Inc. In no event shall any implied warranty exceed the 90 day warranty described above, including without limitation, implied warranties of merchantability and fitness for a particular purpose. In no event shall Paraclipse, Inc. be liable for consequential damages resulting from breach of this warranty or any implied warranty.

Notwithstanding this warranty, any statutory warranty provisions in the state in which this Paraclipse Mosquito Eliminator™ is sold to the final user that are in conflict with or that offer the final users rights superior to those stated herein shall prevail.

This warranty covers defective part(s) only and directly related labor. You are responsible for all cost of diagnosis, shipping, service and handling of the defective unit. Proof of purchase, date and place of purchase will be required.
